LETTER TO INTERN APPLICANTS

Dear Prospective Applicant:

Thank you for your interest in our APA-Accredited Doctoral Internship in Health Psychology and for visiting our web page!

As an internship site that participates in the APPIC Match we use the APPIC Application for Psychology Internship (AAPI Online) and our web site brochure is linked to the APPIC Application for Psychology Internship (AAPI). To access the AAPI,

- 1. Click the link to APPIC in our brochure or
- 2. On your internet browser, type in the APPIC address: http://www.appic.org/
- 3. Follow the instructions regarding how to complete and submit your AAPI online application(s). We are requesting that as part of your APPI, you include a one-page cover letter, providing a summary of how your goals and experience match the opportunities available at our site. Please list and bold the interest areas in which you are interested.

Counseling Services is a department of the Student Health and Counseling Services (SHCS). The Counseling Services internship program is accredited by the American Psychological Association. We are committed to providing quality training experiences in a supportive yet challenging learning environment, which will facilitate your transition from trainee to professional psychologist. Our internship program provides training experiences in primary prevention (through consultation and educational programming) and remedial intervention (through assessment, brief individual psychotherapy, and group psychotherapy).

We emphasize the development of skills, professional identity, and personal growth in a multicultural university environment. The training staff and client population are culturally diverse and Counseling Services is committed to a training process that facilitates the development of professionally relevant knowledge and skills focused on working effectively with all individuals inclusive of demographics, identities, beliefs, attitudes, and values.

The selection process for our internship program involves two steps. Initially, applicants are screened on the basis of the background information they submit in the application packet. Those applicants who are assessed to hold goals and experience most closely matching the availability of training options at Student Health and Counseling Services will be asked to participate in a video format (e.g. Zoom) interview during early January.

The **Application Deadline is November 04, 2022**. We will send an email offering an invitation for interview no later than December 5th, by 6pm PST. Hour long interviews via video conferencing are usually conducted during the first weeks of January but may occur on December 15 or 16th.

Our program has agreed to abide by the APPIC Policy that no member on our staff will solicit, accept or use any ranking related information from any intern applicant. Additionally, I encourage you to discuss with your program training director and then consider reporting to APPIC any program that violates this standard by pressuring you to make a first choice statement.
